REGIONAL HOUSING LEGAL SERIVCES RECEIVES \$28,500 PHILADELPHIA FOUNDATION GRANT TO SUPPORT NEEDED GENERAL OPERATING EXPENSES

Regional Housing Legal Services (RHLS), headquartered in Glenside, was awarded a \$28,500 grant

from the Richard P. Byler Special Interests Fund and the Henry Griffith and Anna Griffith Keasbey Fund of

The Philadelphia Foundation to support general operating expenses. Announcement of the grant was

made by Foundation President R. Andrew Swinney, whose Board of Managers approved the grant on

quality legal, policy, and technical support on affordable housing, community economic development,

and utility issues that we have provided for more than 35 years," said Schwartz.

RHLS is a nonprofit law firm with unique expertise in affordable, sustainable housing and its

related components — community and economic development, utility matters and preservation of

home ownership. RHLS provides innovative project and policy solutions that help create sustainable

communities offering decent, safe and affordable housing for lower-income Pennsylvanians.

RHLS was formed in 1973 to address landlord/tenant issues in what was then known as Lacey

Park, a 110-acre development with 1200 homes established for World War II defense workers in Bucks

County. Today, RHLS has grown to four offices throughout Pennsylvania. RHLS provides:

- legal and technical assistance to nonprofit organizations engaged in affordable housing and economic development projects;
- advocacy on public policy issues related to housing, economic development;

- support to legal services agencies throughout the state on housing-related legal and regulatory developments; and
- •assistance to individuals who are applying for HEMAP loans.
